
Discussion and Recommendation of Targeted Population for Stanislaus County Workforce Development Summer Youth Employment Program for Program Year 2023-2024

STAFF RECOMMENDATION:

Discussion and recommendation of targeted population for Stanislaus County Workforce Development Summer Employment Youth program for program year 2023-2024.

DISCUSSION:

On September 11, 2023, Stanislaus County Workforce Development (SCWD) staff presented to the Youth Development Committee the statistics, eligibility criteria, and outcomes of the Summer Youth Employment program for program year 2022-2023. The program aims to provide valuable work experience and essential skills necessary for navigating the workforce. Eligibility for youth is contingent upon meeting specific criteria: individuals aged 17-21 who are enrolled in school, demonstrate low income status, and possess at least one of the following characteristics: involvement with the justice system, experiencing housing insecurity, English language learners, expectant or parenting, part of a family receiving assistance, or identified as having a disability. The below figure represents the 49 youth participants from the 2023 Summer Youth Employment program:



Based on the information provided, the Workforce Development staff seeks input and recommendations from the Youth Development Committee regarding the ideal target population for the Summer Youth Employment Program for the current program year.

POLICY ISSUE:

1. Call to Order and Introductions

She continued to provide additional information on what the grant will offer to youth with disabilities as well as what Workforce Developments role will be
