



I. Call to Order and Introductions

Committee Vice-Chair, Mary Machado called the March 6, 2023 meeting of the Youth Development Committee (YDC) to order at 1:07 pm. Vice-Chair Machado introduced herself and asked Committee Members and guests to introduce themselves.

II. Conflict of Interest

Stanislaus County Workforce Development (SCWD) Director, Doris Foster reminded Committee Members and guests of the Conflict of Interest Policy.

III. Public Comment Period

There were no public comments.

IV. Chair Report

A. 2023 STANd OUT! Youth Leadership Event Planning

Committee Vice-Chair, Machado shared the upcoming, 3rd Annual STANd Out! Youth Leadership Event is scheduled for July 21st, 2023 at the Martin G. Petersen Events Center. The keynote speaker from previous years has been Jeremy Bates. The YDC is hopeful this motivational speaker will be available again this year. There will be a Planning Committee forming to plan this event with a limit of 3 YDC Members, to avoid conflict with The Brown Act. Committee Vice-Chair, Machado expressed interest in joining again this year and Committee Member, Dallas Plaa volunteered to assist with facilities.

V. Department Report

A. Mid-Year Program Report/Updates

SCWD Coordinator, Andy Fiskum presented the handout of statistics and data of the Workforce Innovation and Opportunity Act (WIOA) Youth Services and the #CaliforniansForAll programs. Director Foster shared that there's an anticipated surplus of about 1 million dollars in funding for youth. Staff will pivot to see how the funding can be used and what other activities we can engage in. A better projection of what SCWD is planning on budgeting for the next fiscal year will be updated in the next meeting.

B. Summer Youth Employment Program

SCWD Manager, Adolph Lopez shared that the Summer Youth Employment Program (SYEP) was operated last year by Ceres Unified School District (CUSD), Project YES. This year, Dulce Piceno of SCWD will be coordinating the program.

Dulce Piceno shared the Summer Youth Employment Program goals, eligibility and current program actions.

Dustin Pack of CUSD, Project YES along with 3 youth worked on a project and gave a presentation of videos they created depicting barriers and/or challenges the youth directly faced with topics such as, mental health, suicide intervention and hope. Committee Vice-Chair Machado stated the videos are very powerful and thanked the youth for their courage of stepping up and wanting to help others.

C. CWA Youth Symposium 2023 Conference

Manager Lopez shared that a few SCWD Staff Members attended the CWA Youth Symposium Conference. The event took place virtually on January 24th through the 26th. Dustin Pack and a couple of youth also participated. The event focused on areas of youth development and was encouraging to our young people to stay engaged.

D. Youth/Community Resource Guide update

Manager Lopez shared there's a variety of different resources available to the community, such as Behavioral Health Services provides an annual resource guide. Health Services Agency also has a family resource directory. In addition to these community directories, there is the 211 website (https://stanislauscounty211.org/). Manager Lopez recommended to the YDC to take advantage of this website. There's a youth link that provides resources specific to youth. Compare the other directories with the 211 website and see which resources are not on the website. The missing resources can then be encouraged to reach out to 211 to be included on their website.

E. StanYEA Youth Summit

StanYEA Youth Summit event will be on March 31, 2023. Dustin Pack and his team are serving on the committee. This event is available to the youth in our community.

F. County Job Fair

The County Job Fair will be at the Martin G. Petersen Events Center on May 12, 2023. Only County Departments will be participating. Let the community know of this hiring event.

VI. Presentation

A. Virtual Career Exploration Program (Transfr Inc)

Stanislaus County Workforce Development has partnered with Transfr Technology. Assistant Director Sara Redd shared that Transfr Career Exploration is a hands-on simulation that showcases different career paths that allows students and job seekers to understand their career options by experiencing in the virtual world.
