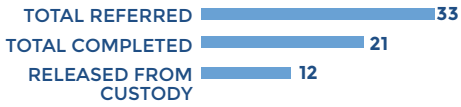

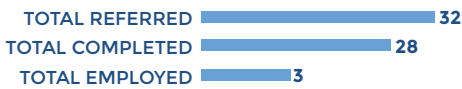

IN-CUSTODY YOUTH



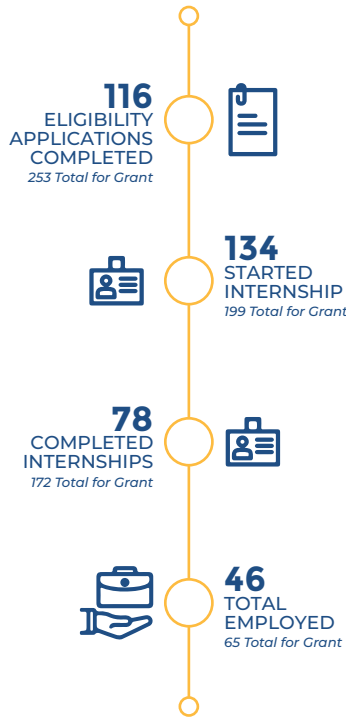
OUT-OF-CUSTODY YOUTH

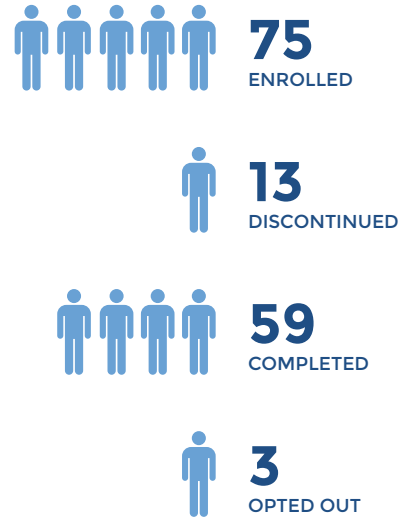

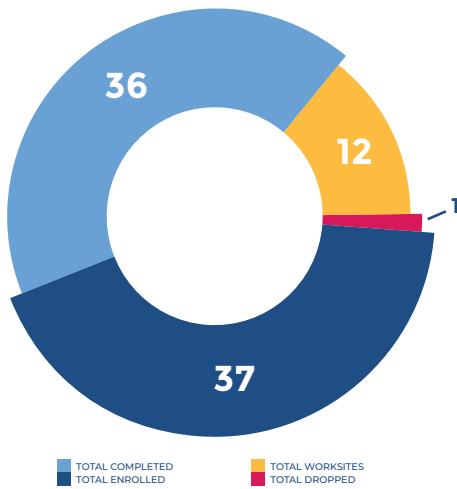


SUMMER YOUTH
